He enjoys tackling challenging matters and especially the opportunity to help individuals and entities in their times of need. ## Representative Results

---

### Complex Commercial Litigation

- In what is believed to be the largest 2021 settlement in Massachusetts, obtained a **\$30 million settlement** on behalf of an auto dealership executive resolving his lawsuit against various defendants for breach of contract and fatally harming the network of auto dealerships
- Obtained a stay order in federal court stopping a lender from liquidating collateral assets to satisfy a \$4 million commercial loan to the firm's client, a medical diagnostics company.
- On behalf of an auto dealership, successfully resolved a dispute with an auto manufacturer resulting in the manufacturer's withdrawal of a franchise termination notice of the auto dealership.
- On behalf of a restaurant chain, resolved a class action lawsuit seeking millions of dollars in damages for \$0.
- Obtained a preliminary injunction on behalf of a business owner requiring a co-owner not to make any decisions regarding the business without his client's consent.
- Obtained summary judgment for business owners establishing that, contrary to claims of plaintiffs, their new venture did not require further approval by a commission overseeing local zoning boards.
- Following a four-day bench trial, obtained a judgment requiring the sale of a Dunkin' Donuts franchise location to his clients.
- Won a jury trial in Massachusetts Superior Court on behalf of a real estate development company defending against a former employee's claim for millions of dollars of company profits.

### Appellate Practice

- Obtained a ruling from the 1st U.S. Circuit Court of Appeals reversing an order finding the guarantor on a commercial real estate loan liable under an indemnity agreement.
- Secured affirmation by the Massachusetts Appeals Court of trial court's ruling ordering sale of business.

### Criminal Defense

- Successfully defended a pain medicine physician at trial in federal court against criminal charges that he violated federal drug distribution laws, resulting in the jury acquitting the physician of all charges.
- Resolved charges against physician accused of criminal drug distribution for the prescription of opioids to chronic pain patients without any prison sentence.

- Secured complete dismissal of criminal charges of mail fraud, false ERISA statements, and other charges brought in federal court against small business owners amounting to \$2 million in alleged but unproven harm.

## Civil Rights

- As cooperating counsel for the ACLU, persuaded a Massachusetts Superior Court judge to [strike as violative of constitutional free speech rights](#) the challenged portions of a school committee's policy on the public's participation in its meetings.
- As cooperating counsel for the ACLU, obtained on a *pro bono* basis a temporary restraining order allowing Occupy Boston protesters to remain encamped in Dewey Square in Boston under the 1st Amendment.
- Won a judgment at trial before the U.S. District Court for the District of Massachusetts (including attorneys' fees and punitive damages) for a businessman whose confidential and largely false criminal record information was published and disseminated publicly, including expunged records that were decades old.
