Melinda L. Thompson, a partner at the firm, concentrates her practice in the areas of government investigations and criminal defense. Ms. Thompson started her career a prosecutor in the Middlesex County District Attorney's Office where she participated in many homicide investigations and trials. She investigated numerous major felonies, including murder, both at the scene and in grand jury proceedings, and tried dozens of Superior Court cases, including armed robbery, armed assault, rape, and murder.

As a prosecutor, Ms. Thompson was committed to prosecuting those responsible for crime while seeking justice for all those involved in the criminal proceedings. She was known as a prosecutor who sought the truth at every stage of the investigation, court hearings and trials.

Ms. Thompson has successfully litigated trials and appeals in state and federal courts. She has obtained numerous alternative resolutions and dismissals on behalf of her clients. Ms. Thompson represents a broad variety of clients including executives undergoing internal investigations, professionals under investigation for alleged corruption, and individuals charged with serious felonies including tax fraud, structuring, mortgage fraud, and violent felonies including sexual assault. Ms. Thompson also represents students under investigation for school and college disciplinary proceedings at every stage of the investigation and appeal.

One of Ms. Thompson's notable achievements is the high-profile "Irish Nanny" case where after over two years of litigation, she persuaded the Massachusetts Office of the Chief Medical Examiner to change its findings regarding the cause of death of the child. The medical examiner changed the cause of death from homicide by shaken baby syndrome to "undetermined," prompting the Middlesex District Attorney's office to dismiss the murder charge against Aisling Brady McCarthy.
