



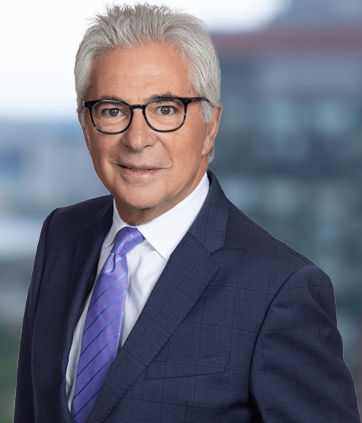

Paul Cirel's notable accomplishments include:

- Represented psychiatrist before the Supreme Judicial Court in a case of first impression establishing that the psychotherapist-patient privilege cannot be pierced even by investigative subpoena
- Successfully represented orthopedic shoe manufacturers/distributors in Attorney General's industry-wide investigation of Medicaid fraud and regulatory compliance
- Secured dismissal of all criminal charges brought against a chiropractic clinic related to a government crackdown on automobile accident insurance fraud
- Successfully resolved four separate Medicaid Fraud investigations of Adult Day Health programs
